# TERMS AND CONDITIONS FOR USING HEFFEL.COM

# **Acceptance**

Heffel through its controlled affiliates located across Canada (Heffel Gallery Limited and Galerie Heffel Québec Ltée., Montréal) and through its international operating division Heffel Fine Art Auction House (collectively, "Heffel") own, operate and maintain, the website located at the domains heffel.com, and related Heffel domains (collectively the "Website"). By using the Website you agree to both these Terms and Conditions ("Terms of Use") and the Terms and Conditions of the Heffel Website *Privacy Policy*, which are incorporated herein by reference. If you do not agree to any of these terms, please do not use the Website. These Terms of Use apply to all users of the Website, including users who are contributors of pictorial, video content, information, and other materials or services on the Website.

#### **Website Access**

The content of the Website is not intended for minors (people who have not reached their eighteenth birthday). Such content extends to a wide range of art, is generally uncensored and may include nudity and / or other graphic or literary content that some people may consider offensive, as well as access to live or electronic bidding on articles that may contain such sensitive content. Such content may be harmful and / or illegal for minors or children and / or inappropriate for them to view or have access to. #### Account

In order to access some features of the Website, you will have to create an account. You are not permitted to use another's account without Heffel's prior written permission. When creating your account, you must provide accurate and complete information. You are solely responsible for the activity that occurs on your account, and you must keep your account password secure. You must notify Heffel immediately of any breach of security or unauthorized use of your account. Although Heffel will not be liable for your losses caused by any unauthorized use of your account, you may be liable for the losses of Heffel or others due to such unauthorized use.

Heffel reserves the right to establish data transfer restrictions and/or limit the total amount of data transfer associated with your account. User accounts may be closed by Heffel should the total amount of data transfer exceed an amount deemed excessive in Heffel's sole discretion.

You agree not to use or launch any automated system, including without limitation, "robots," "spiders," "offline readers," etc., that accesses the Website in a manner that sends more request messages to the Heffel servers in a given period of time than a human can reasonably produce in the same period by using a conventional online web browser. Notwithstanding the foregoing, Heffel grants the operators of public search engines permission to use spiders to copy materials from the site for the sole purpose of creating publicly available searchable indices of the materials, but not caches or archives of such materials. Heffel reserves the right to revoke these exceptions either generally or in specific cases.
